I. Old Business

A. Special Project Requests updates

- i. Temporary bocce ball courts: Two courts have been painted near the 7th Avenue North access. There has been very little observed participation and only two comments received online. One of those comments was not favorable. The GF Park District painted six temporary courts at Lions Park for players to practice for the Special Olympics. Kim will try one more promotional campaign to try sparking interest from the public. She will also try to schedule a meeting with representatives from the Near North Neighborhood group to discuss what their goals would be for that area.
- ii. Boathouse: Use agreement was approved by City Council but has not been signed by both partners. Ground Up Adventures (GUP) is working with JLG Architects on the design of the facility and grounds. Staff has not seen the containers yet. Water and electrical issues are being explored. GUP would like to install a dock for but this may require the installation of piers for stability. The container will need to be inspected by fire department and will require a building permit. Melanie is coordinating this. GUP is scheduled to bring a report to the GF Park District Commissions meeting in October.
- iii. Disc golf course at Riverside Park: The tees and baskets have been installed.
- iv. NASA picture posts toppers: Aubrey has set up the website but the toppers have not arrived yet. Kim is working with the suppliers.
- v. Cabela's wood duck house project: Staff from Cabela's installed the wood duck houses that were constructed during Art Fest. Melanie & Kim met with them recently to discuss working with Cabela's to install more trashcans and benches along the Greenway trail.
- **B. Visual Survey results:** Three visual counts were done this summer. This is good information to help support activities and could be a great project for a UND recreation class to handle in the future.
 - i. Trail users: Results were shared with the committee. The results for the age groups and types of use are very similar to the results from the 2011 count. Biking is the most popular activity and the 19 40 year olds are the highest users. This data will be shared with the MN & ND Departments of Transportation for their bridge studies.
 - **ii. Dog park:** Aubrey conducted the visual studies over the course of two weeks. The most common characteristics of the users were that they arrived in groups and tended to socialize with other park users. Kim will work with Aubrey to compile the data into a report format.
 - **iii. Disc golf:** Aubrey conducted the visual studies over the course of two weeks. Kim will work with Aubrey to compile the data into a report format.

II. New Business

A. Bikeway online survey & comment opportunity: Kim has been working with the Metropolitan Planning Organization to provide opportunities for online comments for the bikeway system. Response has been moderate, with twenty-three responses to date.

Most weekends have a waiting list and tenting is growing in popularity. So far, people from seventeen states have stayed at the campground. Sixty percent of the renters have been from the United States. The trails are very popular with the guests.
- B. GF Park District: Riverside Pool will close on August 25.
- C. City of Grand Forks: No report.
- D. MN DNR: No report.

IV. Other

- **a. Dog park in EGF:** EGF has considered a dog park but Mayor Stauss has not been supportive of the idea. Funding has been an issue.
- **b.** Rollin' on the River: The Friday Night family event for Rollin' on the River will be held in front of the Boardwalk in EGF. A portion of the race on Saturday will use the Greenway trail.






