### **BACKGROUND:**

The project area is part of the Greenway and is located between 47th and 62nd Avenues South. The city owns the property, part of The Greenway, as defined in Grand Forks 14-0402 city code (Exhibit A):

Greenway refers to the physical space controlled by the city council generally described as the wet side of the toe of the levee adjacent to the riverbank, excluding areas leased to the park district and flood protection features such as floodwalls, levees, and pump stations. The greenway generally starts at approximately fifty (50) feet north of the centerline of the north pedestrian bridge, north of Riverside Dam, to the centerline of the south end drainway as more particularly shown on appendix A

Over the years, there have been problems with vandalism and bullying of other users in the undeveloped area. This project aims to improve public access to public land, enhance a fishing area for all users, and provide easier access for law enforcement and emergency responders.

A portion of the project area was originally outside of the city limits when the flood protection system was built after the 1997 flood. The neighborhood east of the project, commonly called the Shady Ridge area, was annexed in 2014.

The property in the project area has been largely undeveloped, and residents have discovered the benefits of this quiet, public space. A small clearing on the riverbank at the stormwater outfall has become a popular area for fishing and river viewing. This area has also attracted unwanted behaviors and vandalism.

The staff has received reports of inappropriate, intimidating, and troubling behaviors coming from various ages of juveniles. Excessive trash, property damage and theft, and bullying of other users have been problems for many years. Trail cameras meant to deter vandalism were stolen, and many trees have been cut down. (Exhibit B) Residents have reported unattended fires and attempts by others to limit public access to the area. The seclusion of this area presents challenges for law enforcement and emergency responders because spring flooding and summer rains make driving vehicles in that area difficult.

Staff worked with KLJ Engineering to develop concept drawings for potential improvements to this area. Those improvements included extending the paved trail south from 47th Avenue South, clearing the area around the fishing site, adding benches and trash cans to the fishing area, adding a small parking lot at the pump station on Desiree Drive on the dry side of the levee, and a trail connection from the parking to the fishing areas. (Exhibit C)

An online survey was made available to residents living adjacent to the proposed project area. A notification letter about the project and survey was sent to 179 residential homes in July 2023. That letter contained project information and a webpage for taking the feedback survey. A follow-up postcard with similar information was sent to the residents one week before the survey closed. Fifty-eight responses were collected. (Exhibit D) Of those collected, one survey was determined to be from someone outside the survey area. The survey allowed for multiple responses from an IP address and device. This allowed households to submit more than one survey.

### ANALYSIS AND FINDINGS OF FACT:

Overall, respondents supported four items in the survey. These totals do not show those who
answered "neutral" on the survey, but that information is available in the full survey response
report.

64% support adding benches and trash receptacles along the trail and at the fishing area.

55% support clearing a larger area at the fishing site.

46% support replacing the current metal retention wall at the fishing site (asked twice on survey).

46% support a paved trail from 47<sup>th</sup> Avenue South to the fishing area.

Two items received a split response.

More defined unpaved trail 38% support, 30% neutral, 32% dislike.

New playground facilities 34% support, 27% neutral, 39% dislike.

 Two items were scored high in dislike by residents, especially from those living on the dry side of Desiree Drive.

Expanded parking at the nearby pump station on Desiree Drive

Overall results: 30% support, 16% neutral, 54% dislike.

Only residents on Desiree Drive: 17% support, 9% neutral, 74% dislike.

A paved trail over the levee from the pump station to the new paved trail


Overall results: 38% support, 14% neutral, 48% dislike.






We have lived in our home since 2015 and the open area, greenway space and natural 8/11/2023 2:59 PM

environment all contributed to our decision to make our home here. Today we watched a fox. Two baby deer with their mother also in the back yard. We have experienced firsthand many of the issues listed above and have sadly earned the reputation in our neighborhood as being "the jerks" because we have asked kids to not access the area by going up our driveway or through our yard. I have allowed people to bike, walk, snowshoe, cross country ski across the bottom of my property without issue. It is those that feel my yard is part of the greenway that creates the problems. Several years ago kids where ordered pizza delivery to our driveway or address to bring down to the fishing area. Two years ago 5 young boys came to our home one Sunday evening. They had 911 on their phone. I spoke to the police. Apparently, men with guns told them to leave the fishing area. Police found the 3 college age men in camo outfits with black airsoft guns. I took the boys in my home until police arrived. Parent's picked them up but not one family talked to me or said thank you. On the west "dike" side of my home is a 20 foot "easement" as part of the drain way. There is a large culvert under this. When I first moved in full sized pickups, 4 wheelers ect actually drove down this path. My then neighbor Cam Tweeten and I had the city out and Cam and I agreed to put in grass and maintain this 20 foot area. There are different maps that define the land differently. There are those who feel this is a public access. We have met with city engineers and staff who have agreed this area is city owned, but not public property. This led to a no trespassing sign being installed several years ago on the south end by Desiree drive by the sidewalk. This will allow the police to enforce as needed. If you look at a map, there are drain easements or public property in the entire neighborhood. Just east of me two homes there is another 20 foot city owned property. Another to the east. For some reason the one on the west edge of my home gets the most attention. Some of this is due to the fact I have not yet fenced in my yard. For those who have fences the space appears more limited and much less inviting. There is also the lazy factor! My lot is right above the fishing area. We had asked to plant a few trees along this area and were told OK as long as we understood that if underground drain needed to be dug up our trees could be in the way. We decided to take the chance only to be asked 8 years later by the city to remove the trees even without the need to access any drains. The tree's where about 6 inches off my property! This has left the area looking more open and more inviting...not helpful. Another concern not mentioned above is the fact that each spring and each time there is significant rainfall the area can completely fill with water. This can occur in a matter of hours. Should we be making this area more inviting? Safety is a huge concern and liability to the city. When the center drain is covered with water there is a huge current pulling to the center. This attracts even more spectators. I have observed on many occasions young kids stand on top of the cement drain. If people would use the public area in consideration, then a better path and access may be helpful. However, for those who like to travel through my yard, it seems to be a tough fix! I do not want to look out and see big blue garbage cans and God forbid and outhouse! There are many walkers, dog walkers, bikers and such that quietly use the area and are very respectful. It is mostly very young boys, unattended or not supervised that create the majority of the issues. What parent let's there 8-year-old or any other age drive the golf cart or 4 wheeler on the dike, greenway and drain way? There are to be no motor vehicles on the above areas. The laws are very clear in regard to this. Enforcement is a major issue. No law enforcement is present in this area. I have seen the police 4 wheeler one time in 8 years. I respect that they are busy, and this is not always on the top of their list of issues! Just another reason to question if more activity is needed in this area. Do the police have the resources to help monitor. The city actually had placed cameras a few years ago and someone threw them in the river! Many nights if the air and wind are just right we can hear every word being said in the fishing area! Some of the context and language is terrible. There is also disruption to the wildlife. Especially with the snowmobiles in the winter. When there is Christmas break some of the kids will drive in the drainway until midnight! Again, no one to enforce the noise or no motor vehicle rules. For those parents who provide these snowmobiles and Cans or loud mufflers, keep them in your yard! Again, plenty of rules and laws. My main issue is with the parents who allow this!
