- Mowing in this area would be increased in this area, which could get to be expensive.
   The City of Grand Forks agrees to absorb the cost of mowing the course area.
- Members of the Greenway & Trail Users Advisory Group asked about disturbing some of the bird habitat in that area. There doesn't appear to be a need to remove trees or vegetation all the way to the river but this could be a sensitive area.
- Installing the course may decrease unwanted activity in the tall grass and trees.

Recommended course of action:

10/11/11: The management of this course would be the same as the second course on the outside edge of Lincoln Drive Park: The City of Grand Forks would mow the area and the disc golf association and Grand Forks Park District would be responsible for maintenance of the baskets and tee pads.
